Forms can be returned to 1125 N. Vine, Room 211 or by fax at 621-4474.

Submit a copy of your signed 2008 U.S. Tax Return (1040, 1040NR, 1040NREZ, or Form 8843) along with this form. U.S. Internal Revenue Service guidelines require all international students to file a tax return. Because this is a federal requirement, your application will not be considered until a copy of your tax return is submitted. If you did not reside in the United States during 2008, please submit a statement to that effect to the Office of Student Financial Aid.

After you complete this form, submit it with a signed copy of your **2008 tax return to the Office of Student Financial Aid**, located in Administration Building, Room 208, Attn: Debbi Golden-Davis.
