## **Quarterly Deadlines**

It is the employee's responsibility to submit the Cost Form referencing the program's monthly and quarterly reimbursement deadlines, in order to receive reimbursement in its entirety for the applicable pay period. Such forms may be submitted as frequently as every two weeks and **must** be submitted at least once a quarter.

Retroactive reimbursements from earlier quarters are not allowed; there are no exceptions\*.
